NOTIFICATION U/S 21 OF LA ACT, 2013

Ukhrul, the 10th May, 2017

No. 10/46/2007-Re(UKL): Whereas, the Governor of Manipur was pleased to notify u/s 11(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 that the land measuring 78.6938 acres described in the schedule annexed thereto are likely to be needed for development of NH-202 from Hundung to Finch Corner on Ukhrul - Imphal Highway vide Notification No.4/37/LA/2007-Com(Rev) dated 22.06.2015 thereby appointed ADM, Ukhrul as Administrator for the purpose of rehabilitation and resettlement.

Whereas, the Governor of Manipur was pleased to notify u/s 19(1) of the said Act that the said area of land is required for development of road NH-202 from Hundung to Finch Corner in Ukhrul District vide Notification No.4/37/LA/2007-Com(Rev) dated 16.12.2016. This declaration was made after hearing of objection and enquiry for rehabilitation and resettlement due to land acquisition.

Now therefore, the undersigned hereby cause public notice that the Government intends to take possession of the land area for development of Double lane National Highway from Hundung to Finch Corner, and that claims to compensations, rehabilitation and resettlement for all interests in the land may be made to the undersigned in writing stating the amount and particulars of their claims to compensation with their objections if any, within 10 June, 2017. And such interested persons shall require to appear personally or by agent or advocate before the Collector by 10.06.2017. No claim shall be entertained thereafter.

No.4/37/LA/2007-Com(Rev) : Whereas, it appears to the Government that a total of 78.6938 acres of land is required in Ukhru District for a public purpose i.e. Development of NH-202(NH-150) from Hundung to Finch corner on Ukhru to Imphal Road.

Therefore, declaration under section 19(1) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 is made that land measuring 78.6938 acres (31.8469 hectares) are under acquisition for the above said project in Ukhru District and the detailed descriptions of Land Schedule are enclosed as Annexure-A.

3. This declaration is made after hearing of objections of persons interested and due enquiry as provided under section 15 of the Right to Fair Compensation and Transparency in Land Acquisition and Resettlement Act, 2013 (30 of 2013). The number of families to get Rehabilitation and Resettlement entitlements due to land acquisition is 72 (seventy two) enclosed as Annexure - B as per the report of the Collector.

4. A plan of the land may be inspected in the office of the Collector, Land Acquisition, Ukhru district on any working day.
